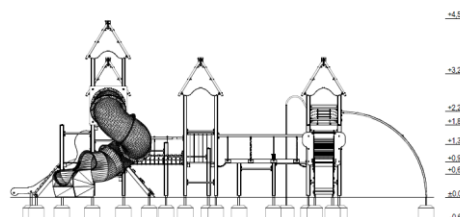
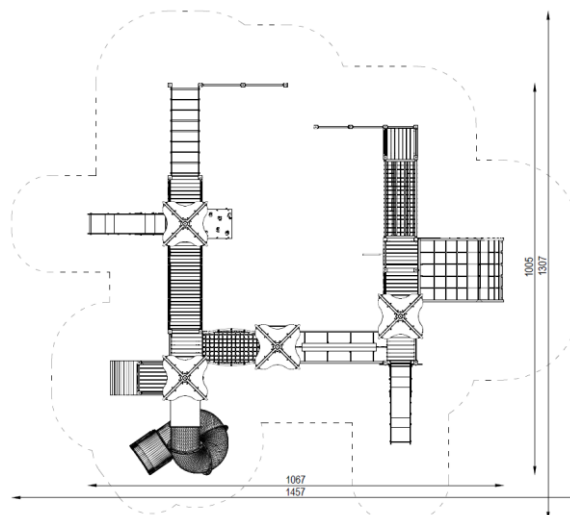

Steel elements:	galvanized steel, powder coated
Chains:	galvanized steel
Surface of slope slide:	stainless steel,
Spiral slide:	polypropylene
Horizontal ladder:	sides made of HDPE board rungs: stainless steel
Climbing walls:	shuttering waterproof plywood, climbing grips, based on resins
Ropes:	polypropylene braided with a steel, interconnected by plastic fasteners
Tic tac toe:	polypropylene rolls,
Caps:	plastic
Foundations:	concrete min. C12/15 standard
